

## RELEASE OF LIABILITY, WAIVER OF LEGAL RIGHTS, ASSUMPTION OF RISK, AND CONSENT TO PHOTOGRAPH

In consideration for the surfing, kiteboarding, and/or stand-up paddle boarding instruction, services, equipment, and/or equipment rental provided by Indo Jax Surf School and/or use of the facilities or premises of Indo Jax Surf School (collectively hereinafter, "Indo Jax Services & Goods"), I hereby understand and voluntarily agree to this Release of Liability, Waiver of Legal Rights, Assumption of Risk and Consent to Photograph (hereinafter, this "Release") as follows:
